We have started installing inlet boxes, pipe and outlet structures on Pickle Road. As of today, we have completed 5 cross pipes and have one more to go.

We have had both mowers running the last few days.

We have started demolition of the concrete in front of our office. We will have all prep work

done this week and the concrete contractor is scheduled for Monday.

Equipment update:

The boom mower auction on Municibid ended today. The winning bid was \$34,255.

The 2003 Mack is in the shop having the frame replaced.

We were asked by the library to bring a few pieces of equipment to their kid's day event

last Saturday. We took the 1999 Mack dump, new boom mower and backhoe down. The library
