APPROVAL OF MINUTES:

Eric Bacon made a motion to approve the minutes from the Board of Supervisors meeting on August 25, 2025, as written. Seconded by, Kent Heffner motion carried unanimously.

NEW BRIDGEVILLE FIRE CO:

Kent Heffner stated they had 36 calls August 16 were medical.

ALLIANCE FIRE & RESCUE SERVICES:

Tyler Burkins stated they had a total of 98 calls, 9 in the Township. Gun Raffle is coming up in September. They had 2 major fires.

SOUTHERN YORK COUNTY EMS, INC. REPORT:

Kent Heffner stated in July there were a total of 157 calls 48 were in the Township mutual aid was received 10 times.

PP&L SUB STATION:

John Wilson stated a draft of the road agreement has been given to PP&L, we are waiting for a number for the bond amount.

BUILDING CODE / ZONING REPORT:

ENGINEERS REPORT:

Grant Anderson reviewed the text amendment to the Stormwater Management Ordinance. Eric Bacon made a motion to advertise the proposed text amendment to the Stormwater Management Ordinance 2025-3. Seconded by Bradley Smith and motion carried.

Grant Anderson and John Wilson reviewed the text amendment to the Subdivision and Land Development Ordinance. The internal process and fees were discussed; the Engineer and Solicitor will review plans at the meetings the Township Secretary will take the plans to the County for recording. John Wilson and Grant Anderson will continue to review and update the amendment and present it at the next Supervisors' meeting.

Grant Anderson and John Wilson reviewed the text amendment to the Solar Ordinance. Bradley Smith made a motion to update set back to One Hundred (100) ft. in the Solar Ordinance. Seconded by Kent Heffner and the motion carried. Eric Bacon made a motion to advertise the proposed text amendment to the Solar Ordinance 2025-4. Seconded by Bradley Smith and motion carried.

Trinity Road Bridges – Bryon DuBois completed the site investigation and issued a report stating there is no bog turtle habitat in the area of the project. GHI will submit the final signed PNDIs with the reports to USFWS when concept plans are complete

Scout Camp Road – Bryon DuBois completed the site investigation and issued a report stating there is no bog turtle habitat in the area of the project. GHI will submit the final signed PNDIs with the reports to USFWS when concept plans are complete.

Fenmore Road – Project application was approved by the DGLVR Program QAB in the amount of \$203,050.00

ROADMASTER'S REPORT:

They have done base repair on Short Cut Road and they would like to put a scratch coat and top it.

believes this does not concern the Township.

John Wilson will contact Christian Miller regarding the Boards decision not to proceed

with the text amendment at this time.

John Wilson will update the model Ordinance from York County regarding the AI Data

Center and prepare for the Planning Commission to review.
